The North River Arts Society's *Holiday Fine Art Sale* will begin with the **Preview Party* on **Thursday, Dec. 1st, 6 - 9pm** and *continues* on **Sat. Dec. 3, 10am - 4pm & Sun. Dec. 4, 1pm - 4pm, and continues Monday through Friday, Dec. 5 through Dec. 9th, Hours: 9:30am - 12:30pm, and Sat. Dec. 10, 10am - 3pm and Sunday Dec 11, Hours: 1pm - 4pm.** *The Holiday Artisan Boutique* will begin with the *Preview Party* on **Dec. 1st, 6 - 9pm** *continues* on **Sat. Dec. 3, 10am - 4pm & Sun. Dec. 4, 1pm - 4pm, is closed during the week, but reopens Sat. Dec. 10, 10am - 3pm and Sunday Dec 11, Hours: 1pm - 4pm.**

*This year, instead of an early bird event on Saturday morning we are excited to host a preview party. For an admission fee of \$10 participants can get first view of the art and receive 10 percent off the art on the stage. Please contact Peggy Bruno at northriverarts@gmail.com with any questions. If you know of anyone who would like to participate in this year's Art Sale or the Artisan Sale, please let us know and we will send information to them.

Fine Art Sale (fine art):

- ❖ Artists may submit up to **25** pieces of work - oil paintings, watercolors, acrylics, etc. - *framed or unframed*.
PLEASE NOTE: Works previously submitted to *any* NRAS Art Sale are **not** eligible for entry. Prints or giclees are allowed, but must be clearly marked as such.
- ❖ Price range is **\$35.00 to \$399.00**. Please keep your prices reasonable to encourage sales. Each artist may submit one piece to the "Gallery on Stage" which is devoted exclusively to higher priced paintings – over **\$400.00**. ***In an effort to promote sales of stage pieces, these paintings will be offered at a 10% discount during the Preview Party event only - discount to be shared by NRAS and the artist.*** All work must be submitted using the enclosed forms.
- ❖ A **\$15.00** handling fee *per artist* will be charged. In addition, for each piece sold, the split will be 70% to NRAS member artists and 30% to NRAS. Non-member artists split will be 50% to the artist and 50% to NRAS for each piece sold. You may become a member at drop-off. Checks will be mailed to artists for total work sold as soon as possible after the Sale.
- ❖ Artists: **HELP US...TO HELP YOU!** We must present a professional appearance for this sale. Please bring your work in appropriate crates or bins (no cardboard boxes, laundry baskets, etc.) Presentation is important for sales! Also, to protect your work and frames, please include separators (cardboard, foamcore, etc.) between each piece in your crate. We will attempt to hang as much work as possible, and will continue to hang pieces as other are sold during the weekend, but much of the work entered is in bins.
- ❖ **IMPORTANT!** Please affix a label to the back of *each piece* of work listing: **your name, title, medium, price, phone #/email address and I.D.# (see sales form).**
EACH PIECE OF FRAMED ART SHOULD ALSO HAVE A LABEL WITH NAME, TITLE, MEDIUM AND PRICE ATTACHED TO THE FRONT. We try to hang as much framed artwork as possible and having the price prominently displayed on the front entices sales.
- ❖ **DELIVER WORK** to the G.A.R. Hall on **Saturday, Nov. 26** from 10:00 a.m.-12:00 p.m. and on **Monday, Nov. 28**, from 7:00 p.m.- 9:00 p.m. Unsold works for **FINE ARTISTS and ARTISANS** may be picked up **Sunday, Dec. 11**, from 3:00-5:00 p.m. or on **Monday, Dec. 12**, from 7:00 p.m.-9:00 p.m. *Works not picked up will be subject to a storage fee of \$5/day.*

Artisans: We are pleased to have the availability of the Firehouse to set up a boutique featuring Artisan work. Note deadlines and pickups listed above.

- ❖ We can accept a limited number of artisan pieces to be displayed "boutique style". The same requirements for fine art participants prevail (\$15 fee and 70:30 split for members; 50:50 split for non-members). WE DO REQUIRE submission of digital images, which can be emailed to northriverarts@gmail.com. **You will be notified of acceptance by email. We will forward further instructions upon that notification.**
- ❖ The boutique will be manned by volunteers. *And any person wishing to volunteer in any way will be very welcome!
