Hall. *NEW THIS YEAR..*we will be offering a limited number of spaces for Artisan booths in our brand new Firehouse facility. We look forward to your participation!

Art Sale (fine art):

- ❖ Artists may submit up to 20 pieces of work - oil paintings, watercolors, acrylics, etc. - *framed or unframed*. **PLEASE NOTE:** Works previously submitted to *any* NRAS Art Sale are **not** eligible for entry.
- ❖ Price range is **\$15.00 to \$399.00**. Please keep your prices reasonable to encourage sales. Each artist may submit one piece in the "Gallery on Stage" which is devoted exclusively to higher priced paintings – over **\$400.00**. All work must be submitted using the forms included here.
- ❖ A **\$10.00** handling fee *per artist* will be charged. In addition, for each piece sold, the split will be 70% to NRAS member artists and 30% to NRAS. Non-member artists split will be 60% to the artist and 40% to NRAS for each piece sold. You may become a member at drop-off. Checks will be mailed to artists for total work sold as soon as possible after the Sale.
- ❖ Artists: **HELP US...TO HELP YOU!** We strongly encourage you to supply functional, yet attractive bins for your display, with some type of buffering materials to prevent damage to your work.
- ❖ **IMPORTANT!** Please affix a label to the back of *each piece of work listing: your name, title, medium, price, phone #/email address and I.D.# (see sales form)*. **EACH PIECE OF FRAMED ARTWORK SHOULD HAVE A PRICE STICKER AFFIXED TO THE FRONT.**
- ❖ **DELIVER WORK** to the G.A.R. Hall on **Saturday, Nov. 5** from 10:00 a.m.-1:00 p.m. and on **Tuesday, Nov. 8**, from 6:00-9:00 p.m. Unsold works may be picked up on **Sunday, Nov. 13**, from 4:00-6:00 p.m., or on **Tuesday, Nov. 15** from 6:00-8:00 p.m. *Works not picked up will be subject to a storage fee of \$5/day.*

Artisans: We are pleased to have the availability of the Firehouse and the ability to include Artisan work. Note deadlines and pickups listed above.

- ❖ There are a **limited number** of spaces available in the Firehouse. Please submit digital photos of your work by **10/21/11** for our review, along with booth fee of **\$90M** and **\$125NM**. Tables and electricity available at extra charge. No additional commissions will be collected from artisan-run booths.
- ❖ For artisans NOT able to man a booth, but wishing to submit a small sampling of their wares, we can accept a **limited number** of pieces, which will be displayed in a "boutique" format, following the same requirements listed for fine artists (\$10 fee and 70/30 split for members; 60/40 split non-members). We do require submission of digital images.
- ❖ You will be notified ASAP if you are accepted or not into the artisan show. We will forward further instructions upon notification. Those not accepted will have fees returned. **There will be no return of fees for no-shows.**
